

# BARS AUDITOR ACCREDITATION COURSE ELIGIBILITY REQUIREMENTS

The cadre of BARS Accredited Auditors comes with a diverse range of operational experience. To ensure that the experience within the program matches the requirements of BARS Member Organizations and Aircraft Operators, only trained and experienced auditors with strong aviation experience can become BARS Accredited Auditors.

All applicants may apply to either the 'Flight Operations' **or** the 'Engineering & Maintenance' disciplines based on their experience, or they can apply as an 'RPAS Auditor'.

All applicants must meet the **General Criteria (Table 1)** and provide evidence of professional experience as listed in the **Further Criteria (Table 2)**.

1.5	Aviation Audits as Lead	2 audits as lead of team of two or more auditors in the last twelve months  RPAS Only Auditor: 'team of two' not required

## License or Certification Evidence Required

1.1 If applying as a **Pilot**, the following additional documentation is required:

- a. Flight qualifications: regulatory authority licences and endorsements
- b. Date of last proficiency currency

2.1 If applying as an **Engineer**, the following additional documentation is required:

- a. Engineering Qualifications: regulatory authority licences and endorsements
- b. Engineering degree, if applicable

3.1 If applying as an **RPAS-only** auditor, the following additional documentation is required:

- a. Your RPAS / Drone qualification / license/s
- b. Brief history of RPAS / Drone pilot / management experience.

## Application Process

To apply, each applicant must:

- Meet the General Criteria (Table 1)
- Provide evidence as listed in the Further Criteria (Table 2)
- Complete an Application Form
- Submit qualification certificates and experience in pdf format in English language
